3 Questions With a CSI Employee - Jeremy Elder - Deputy Director

- 1. What have been the major highlights for CSI this past year? Much like 2020, 2021 feels like a blur. As I look back, we have made some major progress despite the continued challenges that we've faced. We just completed the first cohort of construction and electrical vocational training with the Home Builder's Institute. We launched a partnership with the Lincoln Manufacturing Council to provide manufacturing training and connect participants to employment opportunities in the community. We continued to build opportunities for collaboration through the National Correctional Industries Association (NCIA), the Coordinated Re-Entry Initiative, presenting to the Rentry Alliance of Nebraska (RAN), participating in conferences, and conducting multiple shop tours with local employers and workforce development stakeholders. We also continued investment in CSI including the purchase of a new laser engraver, replacement of our forklift fleet, new license plate equipment, a new CNC, virtual desktop computer infrastructure, and many other investments that will provide job training opportunities to our workforce. We also continued to work to add additional CSI jobs through the full launch of t-shirt production, adding a new private venture operation, developing additional prototype projects, and a soon to be opened consolidated canteen. Since early spring we have assisted Iowa Prison Industries in the production of extruded signs. Finally, our staff received a well-deserved increase in compensation during special contract negotiations.
- 2. How has CSI been able to overcome the challenges that 2020 brought? 2021 has been a challenge as the effects of the pandemic have lingered far longer than anyone hoped and brought additional effects on the economy. During the year, we continued to fill in the gaps when areas are affected by quarantines and absences. That part of the pandemic almost seems routine now. An issue that has become exacerbated by the pandemic is staffing within our facilities. Facility staffing shortages had reduced the number of hours we could operate at some institutions. LCC and TSCI were further impacted as they switched to a Monday through Thursday operational schedule. As with all the challenges in 2020 and beyond, we have been able to succeed only through the initiative and perseverance of our staff and workforce. Our staff has made adjustments to schedules, worked extra hours, and staff has traveled from other shops and locations to contribute where they are needed most. That dedication continues to be a bright spot during these last two years. The other major impact during 2021 has been the limited availability and cost increases of just about any item we purchase. To overcome limited supplies, our buyers are collaborating with vendors more closely and working to build back material inventories. We have launched a comprehensive review of our product pricing to stay current with the economic conditions.
- 3. What message would you like to give the CSI staff for 2022? First and foremost I would say thank you! Our staff makes the difference every day to evaluate the challenges and opportunities in front of them and determine how to make the organization successful. It was wonderful being able to have many of our staff gather together a couple of weeks ago. I look forward to being able to gather together more often in 2022 to showcase the ways you contribute to Keep People Safe within NDCS and how you are Building Opportunities for CSI workers. Here's to a great 2022!
