


University of Nebraska - Kearney Sitka Chairs in Cafeteria!

Department of Administrative Services Display Cases

The Department of Administrative Services was in the process of remodeling their offices. They approached us about fabricating three polycarbonate display cases to house a model ship (USS Nebraska) and two submarines (USS Nebraska, and USS Omaha), replicas of actual U.S. military vessels. They rededicated the updated space with a Nebraska theme.

We had not attempted cases of this design before this point. We accepted the challenge, researched the fabrication process, and are very pleased with the results. The shelves are constructed of Birch hardwood and plywood with a mono-black finish. A dark grey laminate was applied to the shelf as a background for the models. The polycarbonate was cut to size and "welded" together using a special solvent. Two of the models, the ship and one submarine, are displayed on a metal wall.

Magnets were installed on these as no holes could be drilled in the wall. The other submarine is mounted on a typical wall, using a metal hanger system of our own design.

Many staff members were involved in the process, a special thanks to the workers of the NSP and LCC wood shops (Shop 20 and 39). Their skill level, dedication, and willingness to accept new challenges never ceases to impress.
