## DIRECTIONS CLEANING & DEODORIZING TOILET BOWLS

Remove water from bowl by pushing over tap with bowl mop. Holding bowl mop directly over toilet, pour 4 oz. Sparkle Bowl onto mop; thoroungly clean all areas and under flush ring. Flush toilet and rinse out mop.

#### **CLEANING & DEODORIZING URINALS**

Holiding bowl mop directly urinal, pour 4 oz. Sparkle Bowl onto mop. Immediately scrub all surfaces. To deodorize, remove trap screen, pour small amount of Sparkle Bowl into drain opening and scrub. Replace screen and flush Urinal.

For cleaning stainless steel, aluminum, copper, brass, glass, plastic, cement surfaces, tile and grouting on counters and drainboards:

Use 4 oz. Sparkle Bowl to a gallon of water, scrub and rinse thoroughly.

#### HANDLING& STORAGE

When handling wear protective gloves and safety glasses when splashing is likely. Wash hands after handling.

Store between 40 Deg. and 100 Deg. F.
